Food, Health & Nutritional Ingredients Sector Report

Sector Perspectives

Deal activity for Food, Health & Nutritional Ingredients (FHNI) reflected some of the same challenges endured in other sectors in 2022, with M&A volume across all sectors down 37% from historical highs in 2021. That said, 2022 still represented a nice lift from the pandemic-impacted levels of 2020. Alantra observed 99 FHNI transactions in 2022, down 14% from 115 in 2021, but a marked increase from 2020. The dip in FHNI activity, from 2021 to 2022 was much shallower than the market as a whole, and reflects some of the resilience associated with the FHNI sector.

Inflationary pressures that impacted large swaths of the economy in 2022 had a more muted impact on FHNI, where the B2B nature of the business allowed companies to pass along input cost increases. This is particularly true for businesses providing ingredients that contribute to critical flavor, function, or claims profiles for consumer products, as customers are understandably reluctant to change these attributes and risk alienating the end consumer.

Looking ahead, central bank rate increases to curtail inflationary pressures are causing dynamics at some point in 2023. In general, FHNI companies have shown good recession resistance in prior economic downturns. While the specific impact is dependent upon each sub-category of FHNI, the food and health end markets hold up well during economic downturns, as consumers still need to eat and may in fact spend more on preventative health products to avoid larger hospital bills. Accordingly, the ingredients that support these end markets have historically shown similar stability in the face of economic headwinds.

some concern related to potential recessionary

The aforementioned central bank rate increases may have an impact on M&A across the economy, as debt to support private equity deals is more expensive than in years past. At face value, that may cause private equity groups to be more cautious on valuation and result in less competitive pressure for strategic buyers in deal processes. That said, private equity groups still have significant capital to put to work, and are likely to be drawn to recession-resistant categories, such as FHNI. The increase in interest rates should also not directly impact appetite from strategic buyers with longer timelines for their deals.

Trade Show Activity

In November 2022, we attended Supply Side West, and also kept a close eye on themes that arose from Food Ingredients Europe in December 2022. The following are a number of trends we took note of:

Nutrition optimization:

"Good-for-you" and "better-for-you" products remain a hot topic coming out of the pandemic. Propelled by consumer focus on health and wellness in the post-pandemic environment, nutrient profiles are now a key consideration in product development. On a broad scale, we can expect to see less added sugar, increased fiber, and more nutrient dense foods coming from producers. Geared toward the "everyday athlete," protein alternatives and collagen supplements continue to take center stage.





Healthy aging:

Consumers are seeking not just to survive, but to thrive as they reach advanced age. Healthy aging aims to not only promote longevity but places an emphasis on being able to enjoy life with fewer health complications by combatting natural health degradation as one grows old. This includes everything from mental acuity to physical health and a youthful appearance. And consumers are thinking about the long-term effects of what they are putting in their body earlier than ever before. Ingredients that can help promote healthy aging are gaining traction with consumers of all ages.

Gut-health and the microbiome:

The idea of balanced wellness has gone through a recent transformation as consumers seek products contributing to gut-health and the microbiome. This wave

of interest is fueled by developments in microbiome supporting ingredients such as fiber, prebiotics, probiotics, and postbiotics meant to improve sleep, recovery, mood, and other factors that contribute to holistic wellbeing. Special to this field of nutraceuticals, consumers have favored their ability to choose and are moving away from a "one-size-fits-all" approach to gut and brain health. We expect continued consumer demand in this segment as concurrent advancements in the categories of flavors, textures, and formats aid in the adoption of new products hitting the market.

Scientific validation:

Consumers are showing increased interest in health benefit claims on the products they buy, and are seeking clinical validation for those claims. More than half of consumers are influenced by a product's nutritional claims, according to The Food Industry Association, and more consumers are taking the further step of researching label claims. This is pushing producers to seek out ingredients that are backed by strong scientific support, including clinical trials and peer reviewed studies.

Delivery systems:

Largely connected to trends in nutritional convenience, delivery formats and dosage control innovation in the ingredients space is highly incentivized. Groups expanding their capabilities in nutrient delivery are focusing on the consumer experience in their search for new formats such as gummies, powders, chocolates, and even mocktails that can be enjoyed while taking advantage of health benefits and preserving taste. The Nutrition

Business Journal reported that non-pill format sales for supplements have eclipsed traditional pill formats, accounting for about 61% of total supplement sales in 2021 with gummies making up about 21% of total supplement sales.

Sustainability and sourcing:

Consumers and suppliers alike are increasingly sensitive to the impact that their consumption and sourcing has on natural and social environments. Studies have shown that up to 82% of American consumers consider a company's environmental track record in their purchasing decisions. Suppliers have taken notice as they look to find low emission production methods for alternative proteins, regenerative agriculture, and local, scalable sourcing. Both Supply Side West and FI Europe showcased efforts in sustainability by prioritizing carbon neutral vendors and presenting awards to groups that participate in innovative sourcing practices.

Combating food waste:

Mitigating food waste is a multi-faceted issue that has resurfaced at recent trade shows. From increasing supplier yield to consumer usability, producers have continued to work on ways to tackle food waste and responsible resource utilization. Suppliers have showcased the ability for reformulation to extend shelf-life, along with the ability for enzymes to mitigate lesser yield during production. These trends are coupled with manufacturers' efforts to better educate the consumer on "best by" or "use before" dates in an effort to demonstrate the length of time a product may be safe to consume.

Sub-Sector Deep Dive — Branded Nutritional Ingredients

Observed trend

The last two years have seen an acceleration of M&A activity for branded nutritional ingredient businesses. These companies have made for compelling M&A targets, based on (i) underlying momentum in the supplement and functional foods industries helping to drive growth, (ii) strong margin and free cash flow generating profiles, and (iii) "sticky" relationships with customers based on co-branding approaches and functional label claims.

Below are recent examples of branded nutritional ingredient deals. The list reflects a combination of strategic acquirers and financial buyers, as well as branded ingredient portfolios and single ingredient businesses.

More consolidation expected in branded nutritional ingredients

Strategic buyers have shown interest in acquiring branded ingredients as a way to expand their existing portfolios and address a broader range of consumer applications, while potentially offering cross-selling synergies across customer bases. Financial buyers have also been active in the category, attracted by strong growth and cash flow generation profiles, and seeing an opportunity to amass scale through multiple acquisitions in a fragmented segment.

Valuations for these business can reach double-digit EBITDA multiples, and sometimes well into the teens for strong assets. Those deals that touch the higher end of the range often boast one or more of the following: (i) faster growing consumer applications targeted, (ii) higher EBITDA margin profiles (which can range from 15-25%, with some even reaching north of 40%), and (iii) superior IP development and protection in the form of clinical trials, patents, and trademarks. Business with these characteristics will continue to be in high demand from potential acquirers.




